

## Contract for Services

Faces Boston, LLC enters into this contract for On ~ Location makeup services

FACES BOSTON, LLC payment policy is as follows:

1. Initial payment is 50% of total number of bridal party, due and payable by check or Pay Pal, to officially hold your wedding date. (Total cost estimate is based upon initial bridal party participants). This payment is a non-refundable deposit based upon the stated number of services during the initial conversation and the date is saved and "pre-booked" into the FACES BOSTON book of business.
2. Based upon the initial numbers and services requested, the total dollar amount for services will be determined and maybe adjusted before the day of the booked wedding/event. Adjustment may be additional costs, based upon increased services, requiring Faces Boston booking additional artists, travel arrangements (rooms, parking, tolls, travel by air, ferry, etc.) if any, will be paid by Bride in advance of Faces Boston leaving for the venue, with a confirmation for said travel arrangements forwarded to Faces Boston. \* THREE PERSON MINIMUM REQUIREMENT FOR ALL ON ~ LOCATION SERVICES \*
3. The original numbers and associated pricing given by the Bride and Faces Boston are the baseline for total costs. This is due to potentially hiring additional makeup artists, (which affects their schedules if there services are not needed) along with travel costs outside the 35 mile radius of Boston, a. Any and all additional costs will be determined by Faces Boston and with the Bride agreeing to said costs.
4. That stated, the originally determined costs would not be lowered, even if the bridal party participants reduce in number.
5. Final payment of remaining 50% of total costs (original or adjusted) is due and payable by check or Pay pal (see #1.) to Louise Martino 2 WEEKS prior to the booked wedding/event. Faces Boston will send an email reminder that the balance is due and payable to Faces Boston
6. If 10 days prior to the booked wedding/event and there is not an email confirmation to Faces Boston from the Bride stating which credit card to use (the originally used credit card or another credit card) or a pre-determined time to meet for payment between the Bride and Faces Boston, the booking may be forfeited. Again, any travel confirmations need to be forwarded to Faces Boston; Any parking or associated travel costs are to be paid in advance by the Bride in behalf of Faces Boston.
7. **THIS IS IMPORTANT: NO REFUNDS WILL BE GIVEN. THERE ARE NO EXCEPTIONS.** The original 50% secures the booking of the wedding/event date.
8. Once the final payment is paid in full to Faces Boston, **NO REFUNDS WILL BE GIVEN, EXCEPT** in the event that I, Louise Martino am unable to fulfill my obligations due to unforeseen circumstances and cannot find a suitable replacement then 100% of the contract amount less the \$75 consultation fee will be refunded. If a suitable replacement is found there will be no refund.

Faces Boston will be on location for you on your special day. Of all the areas to worry about concerning your wedding day, please, don't let your worry extend to Faces Boston, we will show up.
